Your final designation and booth placement will be determined by the Craft Director, as based on your photo submissions, booth description, and past seniority. The Crafts Director has the final decision concerning any booth, craft vendor, or ruling.

Please note the following:

- Committee will screen, and request removal of any inappropriate items for sale in a booth. All items MUST BE family-friendly! **NO EXCEPTIONS**
- We reserve the right to limit duplications, and/or refusal of booths that do not meet required guidelines for the Jamboree Craft Vendors.
- Retail Trail features retail and semi-handmade items. Recycled or Re-purposed items will be classified according to Craft Director's discretion depending on the items being featured. There are a limited number of retail booth spaces, so retail vendors are first come/first serve only.
